EXECUTIVE ORDER NO. 03-2012

AN ORDER AUTHORIZING THE ADOPTION OF PROGRAM ON CHILD ABUSE PREVENTION AND INTERVENTION AND THE FORMATION OF THE CHILD ABUSE PREVENTION AND INTERVENTION NETWORK (CAPIN) UNDER THE MUNICIPAL COUNCIL FOR THE PROTECTION OF CHILDREN.

WHEREAS, the United Nations Convention on the Rights of the Child affirms the vulnerability of children and that they need the best and most protective mechanisms to ensure their health and the best interests of the child should be a primary concern in all actions;

WHEREAS, every child has an inherent right to life and the State has an obligation to ensure the children survive and develop;

WHEREAS, the Philippine Constitution guarantees the rights of children to children, including special protection from all forms of neglect, abuse, cruelty, oppression and other conditions prejudicial to their development;

WHEREAS, the Municipal Government of Santa Rosa, Pangasinan is committed to uphold its duty to ensure protection and development to ensure the survival, development, protection, and participation of children as mandated by the Constitution;

WHEREAS, one of the rights and duty of children to be protected from all forms of abuse and exploitation;

WHEREAS, there is need to coordinate with with the concerned, technical, and implementation of the plan and action of a municipality based in compliance with the 1987 Local Government Code of the Philippines;

NOW THEREFORE, I, FRANCIS M. PUNDA, Mayor, Municipal Government of Santa Rosa, Pangasinan, by virtue of the power vested in me by law, do hereby make and give the following:

SECTION 1. Program Concept, Purpose, and Creation of a Multidisciplinary Team. RA 7610 mandate government agencies to provide a comprehensive program to protect children and youth against all types of abuse. This shall include a multi-faceted strategy. On the one hand, such government agency program shall be help through various of adult has as well as of appropriate procedures which may cause re-orientation of the child. On the other hand, the child shall be around various agencies where safety is subjected to cognitive and emotional, spiritual, and physical protection in any form and manner to children.

In view of this, the Municipal Government of Santa Rosa, Pangasinan is creating the office to address the crimes of a CHILD ABUSE PREVENTION AND INTERVENTION NETWORK (CAPIN) under the Municipal Council for the Protection of Children.

CAPIN is intended to develop to a group of trained personnel who non government professionals who are mandated to take the child protection in every phase of the helping relationship. These professionals are expected to provide services to an individual and household manner that responds to an abused child's needs in a child friendly way. It will be establish a Multi-Disciplinary Team (MDT) and provide an individual and household that address individual helping strategies

Section 3. Function of CARM. CARM shall ensure that the Protection Rights of Children are upheld, through the following functions:

1. Advocate for the passing of local ordinance (adopting the CARM as a local measure in 2000) to CDMO Board.
2. Facilitate the inclusion of the program and services that protect child victims of abuse, neglect, exploitation, and sexual abuse in conformity with the aim in the local development plan of the Municipality through the Municipal Council for the Protection of Children to ensure sustainability and institutionalization.
3. Assist the local government in handling cases involving children in a professional and child-friendly manner to avoid multiple trauma to a child victim through the collaboration of DENR and Division Professional Units.
4. Develop capacity building programs to CDMO Members in strengthening a system to provide CDMO Board and organization and also interventions for victims of child abuse.
5. Adoption of the Child Case Management Protocol in all members of CARM and
6. Provide and undertake advisory services to promote greater awareness, understanding, and involvement of services for child abuse victims.

Section 4. Secretariat Support. The secretariat shall be lodged in the Municipal Social Welfare and Development Office and shall be responsible for the coordination of the proceedings and meetings, preparation of reports and other necessary documents needed by the committee.

Section 5. Effectivity. This Executive Order shall take effect immediately.
